ANNOUNCEMENT PURSUANT TO RULE 704(5) OF THE LISTING MANUAL

EC World Asset Management Pte. Ltd., in its capacity as manager of EC World Real Estate Investment Trust ("EC World REIT" and as manager of EC World REIT, the "Manager") wishes to update that the refinancing exercise in respect of all of EC World REIT's onshore and offshore term loans due in 2022 is in the final stages of negotiation. The Manager is confident that the refinancing exercise will be completed prior to the maturity dates of the term loans.

In accordance with Rule 704(5) of the Listing Manual of the Singapore Exchange Securities Trading Limited, the Manager wishes to announce that as the outcome of the refinancing exercise is not available as at the date of the Independent Auditors' Report, EC World REIT's auditors, PricewaterhouseCoopers LLP, have in their Independent Auditors' Report ("Independent Auditors' Report") on the financial statements of EC World REIT (the "Financial Statements") for the financial year ended 31 December 2021 ("FY2021"), included an emphasis of matter in respect of material uncertainty related to the ability of EC World REIT and its subsidiaries to refinance their existing borrowings before they become due for repayment.

The Manager would like to highlight that the audit opinion in the Independent Auditors' Report remains unqualified.

The Independent Auditors' Report and the Financial Statements form part of EC World REIT's Annual Report for FY2021 which has been released on SGXNET and despatched to the unitholders of EC World REIT. Unitholders of EC World REIT are advised to read this announcement in conjunction with the Annual Report for FY2021.
